SUMMARY OF INFORMATION:				
On July 11, 2016, the Forsyth County Board of Commissioners adopted a resolution authorizing County staff to apply for a Community Grant from The Winston-Salem Foundation to support the Forsyth County Stepping Up Initiative. On September 30, 2016, the County received notification that the grant application was approved for funding in the amount of \$36,363.				
This grant will be used to provide programming and operating assistance for the Forsyth County Stepping Up Initiative Project aimed at reducing the number of people with co-occurring mental illnesses and substance abuse in local jails.				
The grant will supplement the \$50,000 appropriated in the FY 2017 budget to assist with funding the Stepping Up Initiative Program Manager and Peer Support position plus associated operating costs to implement the Project.				
This grant period is from September 30, 2016 through November 30, 2017. The County may apply for an additional year of grant funding in a declining amount if it is making progress toward achieving grant outcomes.				
The purpose of this item is to authorize execution of the grant contract with The Winston-Salem Foundation and to appropriate the grant funds into the Public Health Department budget for the Stepping Up Initiative.

 - A. Funds will be disbursed to the grantee upon the Foundation's receipt of this signed agreement; a written request for payment; and, if indicated, the satisfactory compliance with any special conditions.
 - B. Any special conditions which apply to the grant should be met promptly. Adequate evidence of compliance with the conditions will be required before the Foundation releases funds.
 - C. Expenses may not be charged against the grant prior to or after the date of the grant period without prior approval of the Foundation.
 - D. The grantee is responsible for grant funds received and for maintaining adequate supporting records consistent with generally accepted accounting practices.
 - E. Equipment or property purchased with grant funds shall be the property of the grantee organization unless the purpose of the organization changes or it should go out of existence. In either case, the equipment or property reverts to the Foundation.
- 3. **REVERSION OF GRANT FUNDS**: The grantee will return to the Foundation any funds not spent by the close of the grant period.

Also, if the Foundation determines that the grantee has breached this agreement, the grant will be canceled and all funds will be promptly returned to the Foundation.
