RESOLUTION ACCEPTING THE HIGHEST BID TO PURCHASE COUNTY OWNED REAL PROPERTY THROUGH NEGOTIATED OFFER, ADVERTISEMENT, AND UPSET BIDS PROCEDURE PURSUANT TO THE PROVISIONS OF N.C.G.S. 160A-269 (BOOKER STREET)

WHEREAS, Forsyth County received an offer in the amount of Two Thousand One Hundred and 00/100 (\$2,100.00) dollars and collected the full amount of the offer from Christopher D. Casey to purchase County owned real property obtained through a property tax foreclosure proceeding and described herein; and

WHEREAS, after due advertisement of the said offer, no upset bids have been received within the time allowed by law; and
