RESOLUTION DECLARING CERTAIN VEHICLES SURPLUS PROPERTY AND APPROVING THE DONATION OF THE SAID PROPERTY TO FAMILY SERVICES, INC. FOR THE "WAYS TO WORK" PROGRAM (DEPARTMENT OF SOCIAL SERVICES)

WHEREAS, Forsyth County owns two vehicles which are no longer useful for County purposes; and

WHEREAS, N.C.G.S. 160A-280, allows counties, to donate to a nonprofit corporation any personal property that the Board of Commissioners deems surplus, obsolete, or unused; and

WHEREAS, County staff recommends that the County vehicles, as identified in the attached letter from David Roddick, Ways to Work Program Manager with Family Services to Kevin Rogers, County Fleet Manager, dated June 23, 2014, which is incorporated herein by reference, be declared surplus and be donated to Family Services, Inc., a nonprofit corporation, incorporated in the State of North Carolina, and that the vehicles be used for the "Ways To Work" Program; and

WHEREAS, the said vehicles would be donated on the conditions that Family Services, Inc. agrees that the vehicles would be used or disposed of and the proceeds thereof used solely to support the "Ways To Work" Program and further agrees to waive all rights to make any claims against Forsyth County relating to any failure of performance of the said vehicles; and

WHEREAS, pursuant to the provisions of N.C.G.S. 160A-280, the Forsyth County Board of Commissioners has caused a public notice of the proposed donation to be posted at least five days prior to the adoption of this Resolution approving the donation.

NOW, THEREFORE, BE IT RESOLVED by the Forsyth County Board of Commissioners that the above-described County vehicles are hereby declared surplus to the needs of Forsyth County due to their mileage and condition.

BE IT FURTHER RESOLVED that the Forsyth County Board of Commissioners hereby approves the donation of the said obsolete, unused, and surplus County vehicles to Family Services, Inc., subject to the conditions set forth herein.

BE IT FURTHER RESOLVED that the Chairman or the County Manager and Clerk to the Board are hereby authorized to execute, on behalf of Forsyth County, the necessary documents to convey title to the said vehicles by donation to Family Services, Inc. pursuant to the provisions of N.C.G.S. 160A-280, on the conditions that said vehicles shall be used or disposed of and the proceeds thereof used by Family Services, Inc. solely to support the "Ways To Work" Program in Forsyth County and that Family Services, Inc. shall waive all rights to make any claims against Forsyth County relating to any failure of performance of the vehicles, to which they agree by accepting title to the vehicles, all subject to a pre-audit certificate thereon by the County Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.

BE IT FURTHER RESOLVED that a public notice of this proposed Resolution has been posted at least five days prior to the adoption of this Resolution approving the donation and this Resolution has been adopted prior to donating the surplus personal property.

That client is a single mother of two children and the car will help her get to work, better care for her children, and rebuild her credit for the future. We do all this while maintaining a loan default rate that averages 12% of less.

Our program is not a handout; it's a hand up. Approximately 66% of clients that get some type of government assistance prior to starting Ways to Work, report that within two years of completing the program, they no longer need government assistance.
