WHEREAS, Mr. Baker has been employed with Salem Baptist Christian School for the past sixteen years and has served as the high school principal for the past eight years; and

WHEREAS, Mark Baker has been very actively involved in his community and church; and

WHEREAS, Mr. Baker served as a member of the Village of Tobaccoville Parks and Recreation Committee from 2001-2007, a member of the Village of Tobaccoville Council from 2007-2012, a volunteer coach of the North Forsyth Little League, and a college and career Sunday school teacher; and

WHEREAS, Mark Baker was appointed Forsyth County Commissioner in District B on January 3, 2013 and his term will expire in December, 2014; and

WHEREAS, during his service as a Forsyth County Commissioner, Mr. Baker served on the Region I EMS Advisory Council, the Piedmont Authority on Regional Transportation (PART), the Transportation Advisory Committee (TAC), and the SciWorks Board of Directors; and

WHEREAS, Mark Baker is most proud of his family; he married his high school sweetheart, Kim, and they have two sons, Zach and Noah;
