RESOLUTION DESIGNATING THE PIEDMONT TRIAD REGIONAL COUNCIL AS THE LEAD AREA AGENCY ON AGING FOR FORSYTH COUNTY FOR STATE FISCAL YEARS 2017 AND 2018
