Appropriation Transfers Report for June 2015

Per Section 2 - Appropriations of the FY2014-2015 Adopted Budget Ordinance, please find the following appropriation transfer(s) processed in June 2015 for the purpose of assuring the administering of programs authorized in the Budget Ordinance. The Ordinance states that such actions are to be reported to the Board at its next Board meeting and recorded in the minutes of that meeting. The appropriation transfers reports consist of:

- 1. Transfers between departments; and/or
- 2. Transfers out of Non-Departmental Contingency; and/or
- 3. Transfers for Departmental Special Gifts received.

During June 2015, five transfers occurred within the first category - Transfers between Departments; one transfer occurred within the second category - Transfers out of Non-Departmental Contingency; and four transfers occurred within the third category - Department Special Gifts Transfer.

Appropriation Transfer(s)

1. A transfer was made from four departments (Emergency Services, Budget and Management, General Services, and Human Resources) to three departments (Interagency Communications, Attorney's Office, and Register of Deeds). These transfers were completed to cover projected year end personal services costs that were projected to be over due to performance adjustments which are not budgeted by the department and for the Register of Deeds, projected Supplemental Register of Deeds retirement would be more than was budgeted - which also means revenues were higher than projected.
