How can you help? Families request assistance with necessary basics (Clothing, shoes, coats, bedding items), as well as other common items that every child deserves.

## **RAPP Sponsorship Process:**

- **Step one:** You notify Teresa Bryant of your desire to sponsor a family. Ms. Bryant will need to know how many people or the size of a family you wish to sponsor.
- **Step two:** Ms. Bryant will match you with a family based on the number of people or size of a family you wish to sponsor.
- Step three: Purchase items you wish to give.
  - Families and the agency are appreciative of any items you are able to purchase from the lists. These lists are a guide; no one expects all items to be purchased.
  - We ask that <u>all caregiver gifts be wrapped</u>.
     Please check the family's list to see if they wish for the children's items to be wrapped. (some families like the joy of wrapping the items themselves for the children they are raising)
- **<u>Step four</u>:** Delivery of your items.
  - Contact Teresa Bryant to schedule a time to drop off your items. This allows
    us to ensure we have staff ready to assist with loading and unloading of your
    donations.
- **Step five:** Items are distributed to families by Friday, 12/18/2009 at 5:00pm.
- **Step six:** You and your group will receive an expression of our appreciation that will include the total numbers served from our project in our community.
