#### I. Call to Order

Ms. Chiles called the meeting to order. Mr. Barnette announced a roll call to verify the attendance, virtually and in-person, of the Advisory Board members.

# II. Approval of the July 18, 2023 Advisory Board Meeting Minutes:

Ms. Chiles opened the discussion for a motion to approve the July 18, 2023 meeting minutes. Ms. Goldsmith made a motion to accept the meeting minutes. Mr. Hutchins seconded the motion. All members in attendance approved. The motion passed.

## III. Director's Update

Mr. Barnette updated the Advisory Board about the recent staff changes. The Senior Office Assistant position was recently filled by a county employee from another department. The Data Specialist and the Senior Environmental Specialist positions are currently vacant. Mr. Barnette commented that compared to the past, there are not many qualifying applications coming in for the more specialized positions in FCOEAP.

Mr. Barnette discussed two grant awards. The first was an award of \$85,000 via an American Rescue Plan Act grant. This was distributed through the EPA, directly to the FCOEAP. The funds were used to buy two continuous particulate matter monitors. These monitors will provide backup, and the FCOEAP can minimize any loss or interruption in data capture in the air monitoring network. Also, under an Inflation Reduction Act-funded Clean Air Act grant program, FCOEAP was awarded \$52,000 with which we will purchase an analyzer for oxides of nitrogen and a multi-gas dilution calibrator.

Mr. Barnette informed the Advisory Board about photovoltaic projects located at the Health and Human Services Campus and at the Forsyth County Government Center.

Mr. Barnette presented a slide show of properties in Forsyth County that are in the process of getting cleaned up, as well as a construction site for a business that was issued a civil penalty for open burning during a burn ban.

#### IV. Other Business

Mr. Barnette confirmed there was no other business.
