Dear Ms. Motsinger:

I am writing in response to your February 15, 2007 letter acknowledging cash payments to nine poll workers in excess of the allowable amount. NC General Statute, Chapter 163 §163-278.8 (f) states "All expenditures for non-media expenses (except postage) of more than fifty dollars (\$50) shall be made by a verifiably form of payment." The rationale for this section of law is to ensure an audit trail is established for every expenditure so that the identity of each payee can be determined.

To meet the intent of the law at this time, the following steps are recommended:

1. Prepare a sworn statement to the NC State Board of Elections that acknowledges this administrative error, states the source of the money, and describes how the funds were converted to cash.
2. Written acknowledgement signed and dated by each poll worker stating their name, address, the amount of cash received, and the date.

Upon receipt of the information, this office will review it and determine if additional information or action is required. Attached please find a form that can be used by the poll workers to acknowledge receipt of the cash payment. Please do not hesitate to contact me if you have additional questions.

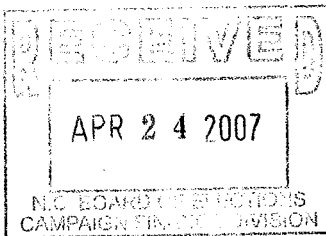

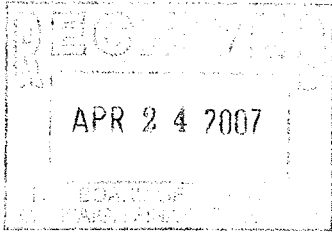
Dear Sir,

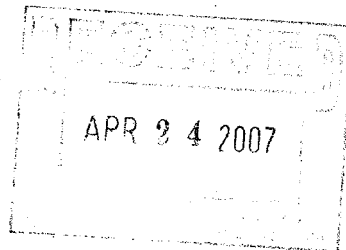
