### Meeting Called to Order

A regular meeting of the Forsyth County Board of Elections was called to order telephonically on May 21, 2020 at 5:00 p.m. Chairperson Campbell presiding.

Chairperson Campbell moved to amend the meeting agenda adding: #6 Approval of Meeting Minutes, #7 Adoption of Resolution Requesting State Board of Elections Assistance in Litigation; and # 8 Approval of Revised FY21 Budget; Member Loughridge seconded; **Motion carried unanimously**.

Chairperson Campbell led the Pledge of Allegiance.

### **Moment of Silence**

Chairperson Campbell called for a moment of silence.

### **Public Comments**

Chairperson Campbell called for public comments, providing three minutes for each speaker:

Chairperson Campbell addressed public comments regarding the Absentee By-Mail request process. Member Loughridge moved to close the public comments; Member Russell seconded; **Motion carried unanimously**.

Chairperson called roll, all Board members were in attendance.

### Discussion on 2020 General Election One-Stop Early Voting Plan

Chairperson Campbell called for discussion of the One-Stop Early Voting plan. The Board discussed previous sites used in the March 3, 2020 Primary as well as the 2016 General Election. Deputy Director Bobadilla provided insight on the libraries and recreation centers, Harper Hill Commons Shopping Center, East Winston Lake YMCA and 14<sup>th</sup> Street Recreation Center, Forsyth Technical Community College and Miller Park Recreation Center. Secretary Durrah moved to table the discussion for future consideration; Member Loughridge seconded; **Motion carried unanimously**.

#### **Approval Meeting Minutes**

Secretary Durrah moved to approve the meeting minutes as presented for April 16, 2020; Chairperson Campbell seconded. **Motion carried unanimously**.

### Adoption of Resolution Requesting SBE Assistance in Litigation

Chairperson Campbell read the Resolution Requesting SBE Assistance in Litigation for members of the public and Board members attending by telephone. Chairperson Campbell moved to adopt the Resolution Requesting SBE Assistance in Litigation; Member Loughridge seconded; **Motion carried unanimously**.

# FY21 Revised Budget

Director Tsujii presented the Board with a revised FY21 Budget and provided insights to the changes to the previously approved budget for consideration and approval. Member Jourdan moved to approve the revised FY21 budget; Secretary Durrah seconded; **Motion carried unanimously**.

# **Other Business**

Director Tsujii provided insight on a Request for Proposal (RFP) in a joint contract opportunity for print and mailing services with the Tax Department, which would improve on the bulk mailing process and cost of voter cards.

Mr. Tsujii addressed the potential for a special primary with the addition of two Winston Salem At-Large City Council seats introduced in NC House Bill 1165. Director Tsujii stated the he had communicated the challenges that exist in meeting the timeline to hold a primary and meet balloting requirements. Member Jourdan inquired about the deadline for signatures of Unaffiliated candidates that have filed petitions to be on the ballot; Ms. Stuck verified the August 5, 2020 due date to certify petitions.

# **Closed Session**

Chairperson Campbell moved to go into closed session to consider the qualifications, competence, performance, or condition of appointment of a public officer or employee or prospective public officer or employee, pursuant to N.C.G.S. 143-318.11(a)(6); Member Loughridge seconded; Motion carried 4-0. (Secretary Durrah was unable to voice his vote due to technical difficulties.) The Board entered closed session at 6:22 p.m.

Secretary Durrah moved to adjourn the Board meeting; Member Loughridge seconded; Motion carried unanimously. Board adjourned at 7:32 p.m.
