## Meeting Called to Order

A meeting of the Forsyth County Board of Elections was called to order in the third floor meeting room on October 04, 2016 at 5:00 p.m., Chairman Raymond presiding.

## **Pledge of Allegiance**

Chairman Raymond led the pledge of allegiance.

## **Moment of Silence**

Chairman Raymond led a moment of silence.

#### **Public Comments**

Chairman Raymond noted no public speakers present for comments. Chairman Raymond called to close public comments; Member El-Amin motioned; Secretary Russell seconded the motion; **Motion carried unanimously.** 

## **Approval of Absentee Ballots**

Ms. Gary recommended 313 Absentee ballots for approval and 2 for disapproval. Ms. Gary stated that to date 582 Absentee ballots have been approved.
