# FORSYTH COUNTY BOARD OF ELECTIONS Meeting Minutes March 12, 2020 – 5:00 p.m.

## Meeting Called to Order

A meeting of the Forsyth County Board of Elections was called to order in the second floor Board Meeting room on March 12, 2020 at 5:01 p.m. Chairperson Campbell presiding.

# **Pledge of Allegiance**

Chairperson Campbell led the Pledge of Allegiance.

Chairperson Campbell led a moment of silence.

# **Public Comments**

Chairperson Campbell called for comments; none provided.

# **Approval of Meeting Minutes**

Member Jourdan moved to table the approval of meeting minutes; Member Russell seconded; **Motion** carried unanimously.

## **Approval of Absentee Ballots**

Deputy Director Bobadilla recommended 397 Civilian absentee ballots; 26 Military/Overseas ballots for approval and 112 for disapproval and 4 absentee ballots for additional review. Member Russell moved to table absentee ballots missing postmark for further research; Member Russell rescinded motion. Member Russell moved to accept staff recommendations for the absentee ballots; Member Loughridge seconded; **Motion carried unanimously**. Member Russell moved to refer the duplicate vote to the District Attorney; Member Loughridge seconded; **Motion carried unanimously**.

# Approval of Provisional Ballots

Director Tsujii presented 94 Provisional ballots for disapproval which included wrong party ballot, no registration, out of county voters, and removed voters; 226 Provisional ballots for approval which included those with ID required presented at office, incorrect precinct – correct ballot, geocode matters, and unreported moves; 173 Provisional ballots for partial approval which included those out of precinct and wrong party ballots.

Chairperson Campbell moved the Board to recess at 8:33 p.m. and brought meeting back from recess at 9:21 p.m.

Ms. Bobadilla presented the Board with the Zero report and Results report to the Board for review.

Deputy Director Bobadilla presented the Absentee report, Absentee Abstract report, Supplemental

#### **Recess**

Member Loughridge moved to recess the Board meeting; Member Russell seconded; Motion carried unanimously. The Board recessed at 9:33 p.m. remaining in recess until March 13, 2020 at 9:00 a.m.

Chairperson Campbell brought the Board meeting back from recess on March 13, 2020 at 9:05 a.m.

Director Tsujii presented the Board with 107 additional Provisional ballots for disapproval; Mr. Tsujii stated that 56 voters who completed a Provisional ballot during Same-Day registration or were required to present ID on Election day did not submit the needed ID, and are being recommended for disapproval. Director Tsujii presented two Provisional ballots to the Board for review that were cast and had a second attempt to vote and recommended disapproval. Director Tsujii recommended 85 Provisional ballots for approval. Secretary Durrah called for a Point of Clarification on the two Provisional ballots which were a second attempt to vote. He moved to disapprove the two provisional ballots and forward both to the District Attorney, Member Russell seconded; **Motion carried 4-0 with Member Jourdan abstaining**. Director Tsujii and the Board discussed the Provisional process and Mr. Tsujii presented an example of the Provisional envelope for review. Director Tsujii presented 25 Provisional ballots for partial approval.

Director Tsujii presented the Zero report, Results report and Cumulative report.

Secretary Durrah moved to adjourn the Supplemental Absentee Board meeting; Member Loughridge seconded; **Motion carried unanimously**. Supplemental Absentee meeting adjourned at 10:47 a.m.
