## FORSYTH COUNTY BOARD OF ELECTIONS Meeting Minutes March 13, 2020 – 9 a.m.

## **Canvas Meeting Called to Order**

A meeting of the Forsyth County Board of Elections was called to order in second floor Board Meeting room on March 13, 2020 at 10:47 a.m. Chairperson Campbell presiding.

**Board Members in attendance**: Chairperson Susan Campbell, Secretary Robert Durrah, Member Stuart Russell, Member John Loughridge, and Member Catherine Jourdan

Staff Members in attendance: Director Tsujii, Deputy Director Michelle Bobadilla, Adam Clark, and Kimberly Stuck

#### **Pledge of Allegiance**

Chairperson Campbell led the Pledge of Allegiance.

#### **Moment of Silence**

Chairperson Campbell led a moment of silence.

#### **Public Comments**

Chairperson Campbell called for comments; none provided.

#### **Approval of Meeting Minutes**

Member Loughridge moved to approve the March 2, 2020 and March 3, 2020 minutes as presented; Secretary Durrah seconded; **Motion carried unanimously**.

## **Report on Hand-to-Eye Sample Audit**

Deputy Director Bobadilla presented the results for the Hand/Eye audit for Precinct 15 – Southeast Middle School and Precinct 033 – St. Andrews Presbyterian Church. Ms. Bobadilla noted that the participants of the audit were Deputy Director Bobadilla, Mr. Robert Phillips, and Ms. Annie Baylor; while being observed by Member Jourdan and Member Loughridge; and no discrepancies were found in the selected Presidential race.

## **Report on Election Audit and Reconciliation**

Mr. Clark provided the report on the Election audit and Reconciliation noting that those that could not reconcile were due to unmarked ballots being inserted to the DS200, voter walking off with the ATV, or ballots failing to be scanned. Tsujii provided an overview of the discrepancies identified and reconciled with regards to provisional ballots that require the Board's review. Secretary Durrah moved to accept the manual edits made; Member Russell seconded; **Motion carried unanimously**.

Chairperson Campbell took the Board into recess at 11:50 a.m.

Chairperson Campbell brought the Board back from recess at 12:23 p.m.

## **Certification of Election Results**

Mr. Clark presented the Board with the Abstracts and Recount Abstracts for review and signature. Member Jourdan moved to certify the March 3, 2020 results; Secretary Durrah seconded; **Motion carried unanimously**.

Chairperson Campbell inquired about possible run-off for the Clerk of Court seat. Director Tsujii stated that the race was a vote for one and that Ms. Hines had 24,696 votes and Ms. Linville-Thompkins had 23,930 votes; which did not meet the 30 percent threshold needed to have a run-off election.

## **Other Business**

The Board and Mr. Tsujii discussed a letter received regarding HeavenView Pentecostal Church; addressing staffing needs and possible options for November.
