## FORSYTH COUNTY BOARD OF ELECTIONS Meeting Minutes February 26, 2021 – 5:00 p.m.

### Meeting Called to Order

A special meeting of the Forsyth County Board of Elections was called to order on January 21, 2021 at 5:05 p.m. with Chairperson Campbell presiding.

#### **Pledge of Allegiance**

Chairperson Campbell led the Pledge of Allegiance.

### Moment of Silence

Chairperson Campbell called for a moment of silence.

### **Public Comments**

Chairperson Campbell called for public comments. There were no public comments.

## **Review of 2020 and Post-Election Report**

Deputy Director Bobadilla presented the 2020 post-annual and November 3, 2020 post-election report to the Board highlighting the accomplishments of the Board of Elections office and lessons learned.

Director Tsujii also presented the strategic goals for the upcoming FY 2021-22 as well as a five year plan outlining long-term goals for 2021-2025.

## **Review and Approval of FY2021-22 Budget**

Director Tsujii provided a detailed overview of the FY 2021-2022 budget to be recommended to the Board of County Commissioners providing insight on intended earmark of contingency funds, office and operations funding, stating that 2021 Municipal Election does generate revenue via the reimbursement process for running the elections for the Municipalities. Member Russell moved to approve the FY 2021-22 budget recommendation, Member Loughridge seconded; **Motion carried unanimously**.

Secretary Durrah moved to approve the meeting minutes for the January 21, 2021 board meeting, Member Russell seconded; **Motion carried unanimously**.
