Public Comment Session

Chairman Raymond opened the public comment session with instructions. Speakers were asked to complete a public comment card and would have three minutes or less to speak. The speaker's name and address should be stated for the record. Questions should be included during the allotted time and answers would be given at the close of the session. A speaker's time could not be given to another individual. At the close of the public comment session, no additional statements or questions would be heard from the public. Secretary Russell moved and Member El-Amin seconded a motion to close the public comment session. **Motion carried unanimously.** In response to public comments, the Board spoke about the issue of the WS/FCS proposal to move precinct 205-Paisley School to Cook Elementary School due to student safety concerns. There has not been any decisions made as of yet and the Board will look to take up the issue in early 2015.

Approval of Minutes

Chairman Raymond requested that the Board members review the minutes of September 17, and September 24, 2014. Registration Deadline Dispute

Mr. Hines informed the Board that there were some faxed voter registrations that were late (after 5pm, Friday, October 10, 2014). The issue was that the time stamp on our receiving fax machine was different than that of the submission fax machine. Member El-Amin moved and Secretary Russell seconded a motion to not accept late registrations in accordance to NCGS 163-82.6(c). **Motion carried unanimously.**

Mr. Hines stated that the registration information is on his desk and the voters will be removed timely.

Approval of Absentee Ballots Returned

Mr. Duffey recommended 468 absentee ballots for approval and 36 absentee ballots for disapproval because of missing information. The voters of the disapproved absentee ballots had been mailed a second ballot and letter of explanation. Secretary Russell moved and Member El-Amin seconded a motion to accept the staff recommendation of 468 absentee ballots for approval and 36 absentee ballots for disapproval. **Motion carried unanimously.**

Director Duties

An updated copy of the duties were submitted with a modification to Duty #3 by adding wording to cover communicating to the Board of any action taken related to personnel issues. Secretary Russell moved and Member El-Amin seconded a motion to accept the Directors duties with this modification. **Motion carried unanimously.**

Other Business

Member El-Amin thanked Mr. Hines for attending the District Court update regarding North Carolina's new voting law (same-day registration and out-of-precinct voting).
