## FORSYTH COUNTY BOARD OF ELECTIONS Meeting Minutes October 27, 2020 – 5:00 p.m.

## Meeting Called to Order

A meeting of the Forsyth County Board of Elections was called to order on October 27, 2020 at 5:03 p.m. Chairperson Campbell presiding.

#### **Pledge of Allegiance**

Chairperson Campbell led the Pledge of Allegiance.

## **Moment of Silence**

Chairperson Campbell called for a moment of silence.

#### **Public Comments**

Chairperson Campbell called for public comments, providing two minutes for each speaker: No public comments.

## **Approval of Meeting Minutes**

Chairperson Campbell moved to approve the October 20<sup>th</sup> and 22<sup>nd</sup>, 2020 meeting minutes; Seconded by Member Loughridge; **Motion carried unanimously**.

#### Approval of Absentee Ballots

Ms. Gary presented 4,293 civilian ballots, 24 military ballots and 51 overseas ballots equaling 4368 ballots that were preliminarily approved. She reported 84 disapproved ballots where 11 were sent cure certifications letters, 15 were re-issued and, 58 spoiled ballots. Ms. Gary reported that 10 cure certification letters were returned.

#### **Pre-processing of Absentee Ballots:**

Pre-processing of absentee ballots began at 5:25 p.m.

The Director asked the Board Members to sign the zero report for both high-speed scanners. All Board Members signed the report.

Director Tsujii presented the Board a list of precinct observers for the dates of October 28<sup>th</sup> to the 31<sup>st</sup> and the replacement name of an At-Large Republican observer. Member Jourdan moved to approve the list; seconded by Secretary Durrah. **Motion carried unanimously.** 

Director Tsujii presented the Board with returned absentee ballots for their consideration. The Director explained that after performing the voter registration list maintenance report, the staff was able to identify a voter who registered to vote in Rockingham County, although he had already voted by absentee by-mail in Forsyth County. Member Loughridge moved to challenge the voter's absentee by-mail ballot; Secretary Durrah amended the motion to add that the ballot be challenged and cancelled at Canvass; seconded by Member Russell. **Motion carried unanimously**.

The second absentee ballot presented to the Board was initially approved, but a second ballot had already been re-issued. Member Loughridge moved to challenge and cancel the ballot at Canvass; seconded by Secretary Durrah. **Motion carried unanimously.** 

Voters that had their ballots challenged by the Board will be properly notified and have the opportunity to join the meeting online at Canvass.

Ms. Gary asked the Board to review three retrived ballots. One returned absentee ballot envelope was missing the voter's signature and two returned absentee ballot envelopes did not contain a ballot.

Ms. Gary reported the revised absentee by-mail numbers: 4,289 civilian ballots, 24 military ballots, 51 overseas ballots, equaling 4,364 ballots. There were 88 disapproved ballots and 46 duplicates. Ten cure certification letters were returned. Secretary Durrah moved to accept the final numbers; seconded by Member Russell. **Motion carried unanimously.** 

Secretary Durrah left the meeting at 9:29 p.m. and returned at 10:07 p.m.

#### **Other Business**

Member Russell moved to cancel the next day's special meeting; Member Jourdan seconded. **Motion carried unanimously.** 

#### <u>Adjournment</u>

Secretary Durrah moved to adjourn the Board meeting; Seconded by Member Russell; Motion carried unanimously.

Meeting adjourned at 11:02 p.m.
