Meeting Called to Order

A meeting of the Forsyth County Board of Elections was called to order in the 2nd Floor Board Room on Thursday, August 22, 2023, at **5:00** p.m., Chairperson Robert Durrah, Jr. presiding.

Forsyth County Board of Elections – Board Meeting August 22, 2023 Lenn Bartley, Elections Training Specialist, presented a list of precinct officials for appointment. Approval of Polling Place Change for Precinct 604

Carma Buchanan, Polling Place Coordinator, recommended to the Board for the adoption of the polling place change for precinct 604, from Forsyth Tech Strickland Center to the National Guard Armory, based on the presentation at the July 18, 2023, meeting. Vice Chair Jourdan moved to approve the polling place change for precinct 604; Member Draper seconded. **Motion carried unanimously.**

<u>Adoption of Resolution of Combined Polling Places for the October 10, 2023,</u> <u>Municipal Primary Election</u>

Carma Buchanan presented to the board the resolution regarding temporary change of polling place assignment for the 2023 City of High Point Municipal Election in Forsyth County, NC. The original polling place, Union Cross Baptist Church- precinct 012, will move to the Hampton Inn in Kernersville- precinct 014 for this election. Vice Chair Jourdan moved to approve the resolution for the change of polling place for the October 10, 2023, election; Secretary Doomy seconded. **Motion carried unanimously.**

<u>Approval of Electioneering Plan at Government Center One-Stop Early Voting</u> <u>Site</u>

Michelle Bobadilla, Deputy Director, presented the electioneering plan for the Government Center One-Stop Early Voting site for the upcoming municipal primary and municipal elections. One parking spot will be dedicated for electioneering in the parking deck. Chestnut Street is now fully open, which will allow for ease of access to the parking deck. Member Draper moved to approve the electioneering plan as presented; Member Harvey seconded. **Motion carried unanimously.**

Adoption of Resolution Regarding the Preparatory Steps to Staff for Absentee Ballots

Louise Lash, Absentee Voting Manager, presented to the Board the resolution regarding delegation to staff of preparatory steps for absentee ballots in the October 10, 2023, primary election and the November 7, 2023, municipal election which follows Numbered Memo 2020-25. Member Draper moved to approve the resolution, Secretary Doomy seconded. **Motion carried unanimously.**

Approval of Pre-Processing Absentee Ballots

Approval of Re-Making Ballot Process

Louise Lash presented to the Board the procedures for remarking ballots that cannot be scanned by the tabulators. Secretary Doomy moved to approve the presented remarking procedures; Member Draper seconded. **Motion carried unanimously.**

Approval of Absentee Disposition Guidelines

Louise Lash presented the absentee disposition guidelines, pursuant to Numbered Memo 2021-03, and informed the Board that this does not include scenarios related to Voter ID. Once information regarding Voter ID is received, the Board will be presented the

Secretary Doomy moved to approve the procedures with the words "and/or" for contacting voters by phone & email; Member Draper seconded. **Motion carried unanimously.**
