FORSYTH COUNTY BOARD OF ELECTIONS Meeting Minutes March 8, 2024 – 1:30 p.m.

Meeting Called to Order

A meeting of the Forsyth County Board of Elections was called to order in the 2nd Floor Board Room on Friday, March 8, 2024, at **1:31** p.m., Chairperson Robert Durrah, Jr. presiding.

Board Members in attendance: Chairperson Robert Durrah, Jr., Vice Chair Catherine Jourdan, Secretary Chad Doomy (1:35 p.m. arrival), Member Alfred Harvey, Member Adam Draper

Staff Members in attendance: Director Tim Tsujii, Tricia Starkey, Adam Clark

Review of Voter ID Exceptions Forms

Director Tsujii presented the Voter ID Exception Forms by category for the Board to review.

An absentee by mail voter is in witness protection and is not able to provide a copy of their identification. Member Draper moved to approve the Voter ID Exception Form; Member Harvey seconded. **Motion carried unanimously.**

A voter forgot their identification at home when voting on election day. Member Harvey moved to accept the Voter ID Exception Form; Member Draper seconded. **Motion carried unanimously.**

Eight voters completed exception forms for having lost, misplaced, or identification stolen. Two of which are missing signatures and have been contacted. Secretary Doomy moved to approve the voter exception forms; Vice Chair Jourdan seconded. **Motion carried unanimously.**

Two voters had expired identification and claimed a reasonable impairment. Vice Chair Jourdan moved to accept the 2 voters exception forms due to reasonable impairments; Secretary Doomy seconded. **Motion carried unanimously.**

Three voters, two of which were from early voting, were not able to obtain identification due to a disability, illness, or lack of transportation. Secretary Doomy moved to approve the 3 exception forms; Member Harvey seconded. **Motion carried unanimously.**

Six voters did not have an acceptable form of identification as they stated that they did not know identification was required for voting. Secretary Doomy moved to accept the exception forms for the six individuals; Member Harvey seconded. **Motion carried unanimously.**

Other Business

Director Tsujii informed the Board that the State of NC would be holding a second primary election on May 14, 2024 for the Republican NC Lieutenant Governor and NC State Auditor races. A draft of the proposed early voting plan for the second primary was provided.

Tricia Starkey, Board Clerk, provided a proposed absentee meeting schedule for the second primary, and provided an update on advertising of the election, absentee meetings, and combined polling places.

Adjournment

Secretary Doomy moved to adjourn; Vice Chair Jourdan seconded. **Motion carried unanimously.** Meeting adjourned at 2:10 p.m.
