- Directors Report
  - Pest control treatment for a verified bed bug
  - Meetings were held for any staff to attend to receive bed bug pest control information presented by Ryan Harrison of Public Health Department
  - o Interim Director has had 9 random staff meetings to date
  - We will put more focus on our Mission and Values and how to tell the DSS story
  - More focus will go to the culture change to identify what habits need changing and reiterating such as returning all calls within the required 24 hour period

## **Strategic/Division Updates**

Professional Development Plan presented by Daphne Taylor

- Discussed the organizational development component
- AGA Federal and State mandates
- CPI reconvened Performance teams
- CM want to be more proactive

Ms. Weston asked how we will effectively make agency-wide communication work better. Mrs. Taylor said we will work to get rid of "turf" areas as well as intentional and unintentional silos.

Hard Launch/Child Care Changes was presented by Kim Collie the focus is on

- building staff confidence with new methodology
- resolving software system issues
- 18 temporary workers will process 50k applications
- We identified 57 parents who lost child care due to being over income limit

Employment Center update given by Diane Wimmer

- Center serves noncustodial parents from Child Support Services program
- Center provides a Job Board accessible to more than the Work First participants
- There are 20 computers in the lab
- Center will identify what other participants it can accommodate

Visitation Rooms report given by Victor Isler

- Staff has concerns
- There has been an increase in need for visitation and transportation
- Judges are including this increase in court orders
- Agency has a goal to increase visitation rooms to 4 or 5
- Pat Read is working with Mr. Isler to identify space that will provide privacy and sound control

Mr. Alston reported the bi-monthly Executive Management Team's focus has been on weekly report sharing and an emphasis on improving customer service.
