#### **Strategic**

The Director passed out and explained the July data for Leading By Results. The Assistant Director informed that the name for the Food Stamps Program is now officially changed to Food and Nutrition Services.

Tanya McDougal, Division Director for Family and Children, along with members of her staff, reported on the Child and Family Services Review conducted October 16-18, 2006. Of the 3 broad areas, Safety, Permanence, and Well-Being, Forsyth County did not achieve substantial conformity in the five outcome areas of Safety and Well-Being. Ms. McDougal reported on the work and progress F&C Division has accomplished toward the Program Improvement Plan. An audit is scheduled for September 13, 2007 and Forsyth County will move from Program Improvement Status once the following target goals have been achieved:

- 4 CPS Assessments case records found in substantial conformity for S1
- 2-4 In-Home Services case records found in substantial conformity for S2
- 2 Child Placement case records in substantial conformity for WB1, WB2, WB3
